Hui Nalu O' Hawaii (Hui Nalu), a 501(c)(3) Domestic Non-Profit Corporation, whose mailing business address is P.O. Box 26342, Honolulu, Hawaii 96825.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Section 11-200.1-15, Hawaii Administrative Rules (HAR) and the Exemption List for the Department of Land and Natural Resources, reviewed and concurred by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an Environmental Assessment pursuant to General Exemption Type 1, "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving minor expansion or minor change of use beyond that previously existing," Item No. 44, which states, "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

JUSTIFICATION FOR REVOCABLE PERMIT:

At this time, staff does not believe that a long-term disposition is appropriate for this area. Satellite photos indicated that a high tide event, between May 2015 and January 2016, removed approximately 25’ of fast land from the canoe storage area. As this area is showing evidence of erosion from sea level rise, staff believes that a revocable permit is an appropriate disposition for the applicant’s request.

REMARKS:

This is an after-the-fact request for Hawaiian racing canoe storage on the fast land near the Ewa shoreline of Maunalua Bay Boat Ramp. Hui Nalu was under the impression that the current area they have been using to store their Hawaiian outrigger racing canoes was a part of a City and County of Honolulu permit obtained by Oahu Hawaiian Canoe Racing Association (OHCRA) for the abutting parcel TMK: (1) 1-3-9-007:032. Upon being notified by staff that the canoe storage area was under Division of Boating and Ocean Recreation (DOBOR) jurisdiction, Hui Nalu submitted an application to use the Premises.

Hui Nalu O’ Hawaii Canoe Club are members of Oahu Hawaiian Canoe Racing Association (OHCRA) which is an affiliate of Hawaiian Canoe Racing Association (HCRA) and meet the requirements of Hawaii Revised Statute (HRS) §200-20 for storing Hawaiian outrigger racing canoes on state shorelines at no charge. However, the Premises is above the highwater mark that defines the shoreline. Therefore, they do not qualify for gratis rent under HRS §200-20.

Hui Nalu, the “Club of the Waves”, was founded in 1908 by Duke Kahanamoku, Knute Cottrell and Ken Winter. Hui Nalu’s mission is to promote and provide education and personal achievement opportunities, which strengthen family, community and individual relationships through ocean education, sports activities, community improvement and Hawaiian traditions. Club members serve as High School Hawaiian outrigger racing

canoe paddling team coaches for Kaiser and Kalani High Schools. Hui Nalu also supports these teams by allowing them to use the club's racing canoes. Along with being a supporter of the community, Hui Nalu has been a good steward of the area. Members of the community have shared that Hui Nalu organizes and participates in beach clean ups of the shoreline adjacent to the canoe storage area. The club applies traditional lashing of their outriggers on site and no other maintenance is performed on the Premises. Hui Nalu has support from many members of the community as attested to by the letters received and attached as **Exhibit B**.

Ka Lahui Kai Canoe Club (Ka Lahui Kai) has also expressed an interest in a revocable permit for a portion of the canoe storage area. In the past, Hui Nalu has shared the area with Ka Lahui Kai. The two club presidents met on site with DOBOR staff and agreed to a demarcation line to share the area. Hui Nalu's area is shown on **Exhibit A-3**. Staff will be presenting Ka Lahui Kai's requested, for Hawaiian racing canoe storage space, in a separate submittal.

RECOMMENDATION:

That the Board of Land and Natural Resources:


1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
2. Authorize the issuance of a Revocable Permit to Hui Nalu O' Hawaii at Maunalua Bay Boat Launch Ramp in the location shown in **Exhibits A-1 thru A-3**, for Hawaiian outrigger racing canoe storage purposes under the terms and conditions cited above, which are by this reference, incorporated herein and further subject to the following:
 - a. The standard terms and conditions of the most current Revocable Permit form, as may be amended from time-to-time; and
 - b. Review and approval by the Department of the Attorney General.
 - c. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

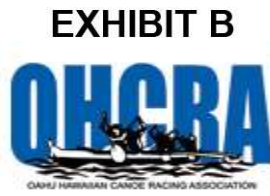
